ORDINANCE 2021-03

AN ORDINANCE ADOPTING A BUSINESS LICENSE OR REGISTRATION FEE

BE IT OBTAINED BY THE GOVERNING BODY OF THE VILLAGE OF MOSQUERO, New Mexico:

SECTION 1. Imposition of Business License Fee. Prior to engaging in any business, any person proposing to engage in business within Village limits shall pay to the Village any applicable business license fee. There is imposed a business license fee of \$35.00. The Business License fee is imposed pursuant to Section 3-38-1 NMSA 1978.

SECTION 2. Imposition of a Business Registration Fee. Prior to conducting any business, any person proposing to conduct business within the municipality shall pay to the Village any applicable business registration fee. There is imposed a business registration fee on each outlet, branch or location within the village limits of the Village of Mosquero of \$35.00. The Business Registration Fee is imposed pursuant to Section 3-38-3 NMSA 1978.

SECTION 3. Application to do Business. Any person proposing to engage in business or conduct business within the municipal village limits of the Village of Mosquero is subject to a business license fee or a business registration fee and shall apply for and pay for a Business License Fee or a Business Registration Fee prior to engaging in business.

SECTION 4. Renewal. Prior to 5:00 P.M. on July 1 of each year, any person with a engaging in business in the Village of Mosquero and subject to this ordinance shall apply for renewal of a business license or registration with the municipal clerk.

SECTION 5. Application. Any person filing a late application for issuance or renewal of any business license or registration shall include in the application his current revenue division taxpayer identification number or evidence of application for a current revenue division taxpayer identification number.

SECTION 6. Late Charges. Any person who fails to renew the business license or registration and pay the fee by 5:00 P.M. on the renewal date of any year shall be charged an additional late fee of \$20.00 and shall not be registered until the original fee and late fee are paid.

SECTION 7. Enforcement. The municipality may enforce payment of the Business License or Registration Fee by filing a charge of violation of this Ordinance in Municipal Court as well as by any of the other means provided in Section 3-38-5 NMSA 1978.


SECTION 8. Severability. Should any section, paragraph, clause or provision of this ordinance, for any reason, be held to be invalid or unenforceable, the invalidity or enforceability of such section, paragraph, clause or provisions shall not affect any of the remaining provisions of this ordinance.


SECTION 9. Repeal. All ordinances or resolutions, or parts thereof, inconsistent herewith are hereby repealed to the extent only of such consistency. The repealer shall not be construed to revive any ordinance or resolution, or part thereof, heretofore repealed.

SECTION 10. Effective Date. The ordinance shall be in full force and effect five days after its adoption, approval and publication by law.
