ORDINANCE 2021-04

AN ORDINANCE RELATING TO THE ANNUAL MUNICIPAL LIQUOR LICENSE TAX UPON THE PRIVILEGE OF PERSONS HOLDING STATE LICENSES UNDER THE PROVISIONS OF CHAPTER 60 OF THE NEW MEXICO STATUTES, 1978 ANNOTATED: FIXING THE AMOUNT OF SUCH LICENSE TAX FOR LIQUOR & SMALL BREWERS AND THE DATES OF PAYMENT OF SUCH TAX: REPEALING AND REPLACING SECTION 3 OF ORDINANCE 13 ½ AND REPEALING ORDINANCE 45 OF THE VILLAGE OF MOSQUERO, HARDING COUNTY, NEW MEXICO

BE IT ORDAINED BY THE GOVERNING BODY OF THE VILLAGE OF MOSQUERO, NEW MEXICO

Section 1. The following section of Ordinance 13 ½ of the Village of Mosquero is hereby repealed and replaced as follows:

Pursuant to the provisions of §7-24-1, et seq. N.M.S.A. 1978, no person shall operate a business as a retailer, restaurant, dispenser or club that dispense or sells alcoholic beverages, beer or wine without first having been issued a New Mexico state license and having paid the municipal license tax.

Liquor License Tax

- A. There is hereby imposed an annual liquor license upon the privilege of persons holding state license under the laws of the State of New Mexico to operate as retailers within the limits of the Village of Mosquero, New Mexico; This liquor license tax is hereby fixed at \$250.00 per year; This license shall begin July 1 of each year and continue through June 30 of the following year.

Small Brewer License Tax

- B. There is hereby imposed an annual liquor license upon the privilege of persons holding state license under the laws of the State of New Mexico to operate as a dispenser within the limits of the Village of Mosquero, New Mexico; This liquor license tax is hereby fixed at \$150.00 per year; This license shall begin July 1 of each year and continue through June 30 of the following year.

Special Dispenser's Permit

- C. Persons granted a special dispenser's permit, under the provisions of §60-6A-12, N.M.S.A. 1978, shall pay to the Village a fee of fifty dollars (\$50.00) for the special dispenser's permit plus a fee of twenty-five dollars (\$25.00) per day for each day the permittee dispenses alcoholic beverages.

Payment of License Tax

The annual license tax is due upon issuance of the license and thereafter must be renewed annually and must be paid before July 1st of each year.

Such Liquor & Small Brewer license tax may be paid in equal quarterly installments payable on or before the commencement date of each of the respective quarterly periods.

Quarterly license to be issued for the period commencing July 1 of each year;

Quarterly license to be issued for the period commencing October 1 of each year;


Quarterly license to be issued for the period commencing January 1 of each year;


Quarterly license to be issued for the period commencing April 1 of each year;
